Friday morning at 8:30 am the Trustee's meeting will reconvene in the Marie Antoinette Room to complete Committee reports and finalize the budget.

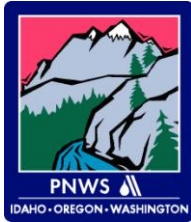
